A weight of 109 kg (240 lb.) shall be secured in the center of the seat. Apply a 445 N (100 lbf.) total force to the backrest at the specified position at a rate between 10 and 30 cycles per minute. For chairs with backrest widths less than or equal to 406 mm (16 in.) at the height of the loading point, apply the load to the backrest for 120,000 cycles. For chairs with backrest widths greater than 406 mm (16 in.) at the height of the loading point, apply the load to the backrest for 80,000 cycles + 20,000 cycles at the position 102 mm (4 in.) to the right of the vertical centerline + 20,000 cycles at the position 102 mm (4 in.) to the left of the vertical centerline There shall be no loss of serviceability. Note: With the backrest at its back stop position, apply a force that is initially 90 degrees ± 10 degrees to the plane of the backrest. The force is not intended to be maintained at 90 degrees ± 10 degrees throughout the loading of the backrest.	PASS
